## **Conservation Director (Tyler L.):**

- Contacted MN Darkhouse/Anglers association about potentially working with the Sheriff's Dept for Lake cleanup-contacted Marty Hoffmeister
- Mickey discussed Lake Minnetonka (Halstead Bay) development proposal involving 1109 housing units and 129 new docks. Developer amended proposal to 121 after initial public hearing. LMCD has voted for 117 with amendments and a fact finding session.
- LMCD is in the process of dropping tournament permit requirement for Lake Minnetonka

## **Youth Director (Chris G.): Not Present**

- Discussed potential dates for best time to hold Casting Kids event at Cabin Fever. Visiting with Jeff (owner) next week and will email club on dates.

## **Old Business:**

- Phil B discussed a \$500 deposit needed for Cabin rental at Whitefish for TOC. Townhomes cost \$1395/week Cabins @ \$975/week, both sleep 6 with 5 beds and pullout couch. 13 people with a show of hands for potential attendance.
- Club voted that non-refundable deposits of \$50.00 be presented by attendees by April meeting. Also that \$1000.00 deposit be sent to Beacon Shores resort immediately.

## **New Business:**

- Bylaws discussed. New "revised: Bylaws to be posted on website.
- Sportsman of the year Secret ballot voting conducted.
- Fed bylaw changes ballot passed around and member voted on new proposals including - dollar limit for spending increasing to \$2000.00 due to economic and inflation factors. - Provisions to change Bylaws to allow Fed Reps alone to vote on issues due to lack of attendance to meetings and lack of votes.
- Provision discussed to allow clubs who sponsor "Jr. Clubs" to receive an additional guaranteed boater slot at TOC to encourage clubs to sponsor Jr clubs. Proposal for Board of Directors to also receive a slot at TOC for same reasons.
- MNBFN Skeeter silent auction bidding starting Feb 21st ending Apr 8th with minimum starting bid of \$24500.00
- Bill Young passed out new club calendar."Thanks Bill"

## **Education (Phil B.):**

- Jeff did a presentation on Frogs and Frog modifications
- Brent did a presentation on "Dos and Dont's" of tournament fishing and "Lessons Learned from the boater" Also discussed tournament strategies and Baby Brush Hogs as favorite lure.
